**2) MINUTES OF THE 9TH MARCH 2015 ANNUAL GENERAL MEETING (AGM)**

**JJ** asked that two corrections be noted to the Minutes of the AGM

### **3) REPORT ON 2015 LEAGUE COMPETITIONS**

#### **3.1 Summer Leagues**

##### **3.1.1 Adults**

**JJ** presented a brief summary.

Two teams withdrew before the start of the season which was unfortunate.

Despite a weather affected season the majority of matches were completed.

Most matches were correctly reported though not all results were confirmed by losing captains.

There was 1 fixture unplayed by the end of August so no points were awarded to either team.

There were 10 fixtures forfeited with penalty points applied. This happened mostly towards the end of the season and as holidays were taken.

**JB, TW, & TA** reported that there were no particular administration problems and thanked teams for inputting results in a timely manner. Teams are reminded to advise co-ordinators promptly of rescheduled match dates and to check and retain a copy of the scoresheet from each match.

Feedback was requested from teams competing in the Medley competition and whether there was any interest in reviving the Mixed competition.

Audrey Reed, Chapel Allerton, commented that they had enjoyed the Medley format and that the male players had welcomed the opportunity to play Mens doubles.

**N.B.** It is the intention of the League to offer just the Medley competition in 2016 unless feedback to the contrary is received.

##### **3.1.2 Juniors**

**MS** reported that it had been a good season for the Juniors though some matches remained unplayed due to weather and the difficulty of rescheduling.

Matches were played in a very sporting manner and all players are congratulated on their conduct which was a credit to their Clubs and the League. Because of this the Fair Play Shield has not be awarded to an individual team. Presentations to the winners of the Junior age groups were then made.

##### **3.2 Winter League**

**GT** reported that due to uncertainties at Leeds Beckett University the court booking was only confirmed in early September. However the League is now fully up and running with allocated nights of Monday and Tuesday.

The majority of teams have sent in their entry fees.

Teams are asked to enter and confirm results as soon as possible after matches.

##### **3.3 Veterans League**

**MG** advised that 4 teams have competed in the summer.

He will contact the teams to see if there is interest in playing through the Winter.

New entrants are encouraged. Details of how to enter and the rules of the competition are available on the League website. Please contact Mike Green.

##### **3.4 Singles League**

**DB** reported that the Singles League remains active. The August to December period is the quietest but there are new entrants lined up for the round robin starting in January.

### **4) FINANCE**

**GW** presented a report on the League's finances and accounts.

The full report is attached to these Minutes which **GW** summarised as follows:

- Summer league entry in 2015 was free
- Singles league has generated fees of £120. New entrants pay a one off charge of £10.
- Winter league fees remain at £90 per team.
- Expenditure has been kept to £250, including the purchase of replica trophies
- The League has £8160 in the bank which includes £2016 of Winter League fees received with £1080 due
- Provisions are held for Website upgrade of £1541 and Secretarial/Admin £1250.
- After allowing for these provisions the League has general reserves of £4250.

The Committee has approved another waiver to Summer and Veteran League entry fees for 2016. **DR** then informed the meeting that **GW** would be standing down as Treasurer at the 2016 AGM after 6 years in the post. He thanked Gary for his hard work and contribution and this was recognised by a round of applause.

**5) WEBSITE AND IT MATTERS**

**5.1 Website**

**SB** reported that a small payment is made to 1&1 for website hosting which is covered by the reserve in the accounts.

Feedback is welcomed on the site and also suggestions for additions. Please pass this through **JJ**.

**5.2 IT**

All players with BTM numbers are imported to the database at the start of each year. Those players where a BTM number is not quoted are not transferred. It was noted that some players are named twice where one entry has a BTM number and the other does not. This affects player statistics. It is recommended that at the start of the season when a result is entered for the first time that squad players and BTM numbers are filled in so the details are set up correctly.

There is still an issue with results being confirmed when input, rather than by the losing captain. We are unable to do anything other than to remind users to be aware of this so when inputting results please press **“save”** rather than **“confirm”**.

At matches captains are also reminded to record names of all players and enter correctly on the database. The administrators can make changes but this cannot be done at club level.

Log In and Password codes are unique to each Club. Please try to avoid this but should a password change be requested, or become necessary, raise this through **JJ**.
